

# ENROLLMENT

We ask all patrons wishing to enroll their child in the Family Child Care Program to visit [www.militarychildcare.com](http://www.militarychildcare.com).

Parents are responsible for selecting their child's provider and must complete all registration forms (AF1181 and the General Enrollment Form) with their provider of choice. Parents seeking subsidy support must schedule a time with the FCC Coordinator to have their fees evaluated, and must attach a copy of the most current Leave and Earnings Statement/Payroll Statement of both the sponsor and spouse.

# FAMILY CHILD CARE

# WHAT WE DO

The Moody AFB Family Child Care (FCC) is the care of children in affiliated homes, either privatized base housing or off-base homes. The Family Child Care Program provides an alternative to center-based care for families that need evening care, weekend care, care for children with special needs, infants, and school-age children and care during swing and midnight shifts.

## OUR MISSION STATEMENT

To assist all DoD military and civilian personnel in balancing the competing demands of accomplishing the DoD mission and managing family life, we aim to deliver a system of quality, accessible, and affordable programs and services for eligible children and youth, from birth through 18 years of age.



# FACILITY INFORMATION

## ELIGIBILITY & PARTICIPATION

All children ages two weeks through 12 years of age of any Active Duty member, Reserve member during Primary UTA weekends and annual training, civilian employee or contractor employed at Moody AFB are eligible. Child care is provided on an equal opportunity basis in all FCC homes. Parents must sign a contract, which will be maintained by the provider. All children are required to have up-to-date immunizations. Any child who has a chronic health problem, including HIV-positive children, will not be discriminated against.

## HOURS & FEES

Each Family Child Care provider determines his or her hours of operation. The FCC also provides child care for volunteers and a subsidy program. Visit the FCC page at [www.moody23fss.com](http://www.moody23fss.com) for more information.

## PERMANENT CHANGE OF STATION CARE (PCS CARE)

Families can apply for \$200 per eligible dependent, up to age 12, through AFAS (Air & Space Forces Aid Society) to pay providers or any child care option directly. Must apply within 60 days of arrival or departure. Visit <https://afas.org/ccfpcs/> for more information.

# EXPANDED CHILD CARE

The ECC program assists families with any special circumstances concerning child care. Expanded Child Care programs include:

- **Extended Duty Care (EDC)**  
Available during non-traditional hours for parents working temporarily extended or additional shifts to support the mission.
- **Emergency Medical Care (EMC)**  
Provides care for families who are experiencing an emergency medical issue with an immediate family member.
- **Pre-Deployment Care (PDCC) & Deployment Care (DCC)**  
Provides 16 hours of monthly care per child for children 12 and under to those deploying for more than 30 days. A completed AF FCC ECC form to include a signature from the sponsor's supervisor and a copy of orders are needed at least three business days prior to the needed date of care.
- **Returning Home Care (RHC)**  
Child care for eligible members returning after a minimum 30 day deployment in support of a contingency operation, after a series of short-term deployments totaling 30 days in a six month period or during member's two week R&R leave from a deployed location.
- **ANG/AFR Home Community Care (HCC)**  
Allows ANG/AFR parents to use licensed and affiliated FCC homes on drill weekends.
- **Military Spouse Appointment Care**  
Provides care when a spouse attends an approved appointment while the sponsor is at work, at directed crew rest or attending the appointment with the spouse.
